BADGER WELL-BEING CHALLENGE INCENTIVE PROGRAM

OFFICIAL RULES

THERE IS NO COST TO PARTICIPATE IN THE BADGER WELL-BEING CHALLENGE. SEE BELOW FOR OFFICIAL RULES REGARDING PARTICIPATION ELGIBITILY. - 1. ELIGIBILITY: Those who are eligible in accordance with these Official Rules may participate in the Program. This Program is limited to individuals who are: (1) freshmen or sophomores enrolled at the University of Wisconsin-Madison as of the start of the Fall 2021 semester; (2) legal residents of the United States or the District of Columbia; (3) at least eighteen (18) years old at the time of entry; (4) did not make any purchase or payment for the purpose of entering this Program; and (5) have completed the Initial Assessment and the Improvement Assessment conducted by Sponsor during the Entry Period. Any employee, officer or director of Sponsor, its affiliates, subsidiaries, advertising and promotional agencies or an immediate family member of or household resident with such persons are not eligible. As used in these Official Rules, "immediate family member" means spouse, domestic partner, parent, step-parent, child, step-child, sibling, step-sibling, grandparent, and any spouse, domestic partner or "step" of such person, regardless of where they reside. Entrants agree to be bound by these Official Rules and the decisions of Sponsor with respect to the Program, which shall be final and binding.
- ENTRY PERIOD: The Program beings at 9am Central Time ("CT") on September 1, 2021 and ends at 11:59pm CT on 10/31/2021 (the "Entry Period"). Sponsor's designated computer is the official time clock for this Program. Proof of transmission (screenshots or captures, etc.) does not constitute proof of receipt.
- HOW TO ENTER; ENTRIES: Eligible participants who have completed Sponsor's assessment on overall well-being ("Initial Assessment") and assessment on well-being improvements ("Improvement Assessment") during the Entry Period are automatically entered. Limit one (1) entry per eligible participant.
- **4. PRIZES; ODDS:** After applicable verification and subject to compliance with these Official Rules, twenty (20) selected entrants from the random drawing in this Program will receive the following prize: \$50 Amazon E-Gift Card. The total value of all prizes is \$1,000. Odds of winning a prize depends on the total number of entries received during the Entry Period.

No exchange, assignment, transfer, or substitution of prizes permitted except where required by law. Prizes are non-refundable, not convertible to cash, and cannot be replaced if lost or stolen. If any prize becomes unavailable or cannot be awarded for any reason, Sponsor may substitute a prize of equal or greater value, including, without limitation, a cash award. Taxes and duties on the prize and expenses related to acceptance, delivery, and use of the prize, are the sole responsibility of the prize winner. Prize will be sent within two weeks after winner confirmation, as described below.

- 5. WINNER SELECTION AND NOTIFICATION: Twenty entries will be selected in a random drawing conducted on or about November 3, 2021 at the Program Address at approximately 12pm CT. Sponsor will attempt to notify the selected entrants within one week of the drawing. To be confirmed a winner, the selected entrant must respond to the prize notification and complete Sponsor's Affidavit of Eligibility and Liability and Publicity Release (the "Release") within two weeks of attempted notification. If a selected entrant is unable to be confirmed as a winner as above, his/her opportunity to receive a prize may be forfeited and awarded to an alternate entrant. EACH PARTICIPANT FURTHER AGREES THAT IN ANY CAUSE OF ACTION, THE PROGRAM PARTIES' LIABILITY WILL BE LIMITED TO THE COST OF PARTICIPATING IN THE PROGRAM, AND IN NO EVENT SHALL THE PROGRAM PARTIES BE LIABLE FOR ATTORNEYS' FEES, PUNITIVE, CONSEQUENTIAL, DIRECT OR INDIRECT DAMAGES AND EACH PARTICIPANT WAIVES THE RIGHT TO CLAIM ANY DAMAGES WHATSOEVER. THE WINNER OF ANY PRIZE SHALL BEAR ALL RISK OF LOSS OR DAMAGE TO THE PRIZE OR ANY PRIZE ELEMENTS AFTER IT HAS BEEN DELIVERED OR MADE AVAILABLE.

DISPUTES:** Except where prohibited, participants agree that: (1) to the extent permitted by applicable law, any and all disputes, claims, and causes of action arising out of or connected with this Program or any prize awarded shall be resolved individually, without any form of class action, and exclusively by the United States District Court encompassing Madison, Wisconsin or the appropriate State Court of the State of Wisconsin encompassing Madison, Wisconsin; (2) any and all claims, judgments, and

awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Program, but in no event attorneys' fees; and (3) under no circumstances will participants be permitted to obtain awards for, and participants hereby waive all rights to claim, indirect, punitive, incidental, and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. If for any reason the Program is not capable of being conducted as contemplated in these Official Rules, including if due to tampering or technical failures which compromise the administration or integrity of the Program, Sponsor, in its sole discretion, reserves the right to terminate or modify the Program. All entries become the property of the Sponsor and none will be returned. The Program is not sponsored, endorsed, or associated with Amazon or the University of Wisconsin-Madison.
